Contest Rules

These contest rules are specific to the above contest conducted by Audacy California, LLC d/b/a KUDL (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. When the “cue to call” is announced, caller seventeen(17) to the Station’s contest line at (916) 909 - 1065 will be given the opportunity to select one of forty(40) envelopes by selecting a number between one(1) and forty(40). There will be a total of forty(40) envelopes will be available in this Contest and each will be assigned a number between one(1) and forty(40) prior to the commencement of this Contest. If a caller selects a number that was previously selected by another caller in this Contest, that caller will not be a winner in this Contest. If the caller selects a number that has not been selected by a previous contestant in this Contest, that person will win the prize assigned to that number, subject to verification of eligibility. There will be no less than two (2) Contest plays per contesting day.
