

ROAD TO STAGECOACH CONTEST RULES

These contest rules are specific to the above contest conducted by Audacy San Diego, LLC d/b/a KSON-FM (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. To the extent that the general contest rules differ from these rules, these rules will govern and control with respect to this Contest.

How to Enter

1. No purchase or payment of any kind is necessary to enter or win the Road to Stagecoach (the “**Contest**”). A purchase or payment will not increase your chance of winning.

From 12:00 AM PT on January 31, 2022 through the earlier of either at on April 22, 2022 or the point at which one-hundred and fifty (150) have been awarded in this Contest, whichever is sooner, go to www.kson.com/contests, click on the link to enter this Contest, and complete the entry form with all applicable and required information. **THE CONTEST WILL NOT BE CONDUCTED ON FEBRUARY 21, 2022.**
