KSON's Friendsgiving: Taylor Swift Tickets Contest Rules

These contest rules are specific to the above contest conducted by Audacy California LLC d/b/a KSON-FM (the "Station"). Except to the extent specifically set forth below with respect to this specific contest, the Station's general contest rules apply to this Contest as well. How to Enter

- No purchase or payment of any kind is necessary to enter or win KSON's Friendsgiving: Taylor Swift Tickets contest (the "Contest"). A purchase or payment will not increase your chance of winning.
- 2. Eligible Nominees must both be eighteen (18) years of age or older and legally reside in San Diego County as of the date of entry in this Contest (each a "Nominee").
 - a. Individuals may make Nominations (each, a "Nominator") starting at 5:00 PM PT on November 13, 2022 and ending at 12:00 AM PT on November 18, 2022 by means of submissions to the Station by completing the form on the Station's website https://www.audacy.com/kson/contests, by clicking on the "KSON's Friendsgiving: Taylor Swift Tickets" page and submit all of the following materials:
 - Nominator's contact information including Nominator's full name, address of legal residence, phone i. number (including area code), date of birth, select a gender, and e-mail address.
 - The name, address, age, and telephone number (including area code) of the Nominee that you are ii. nominating in this Contest; and
 - iii. A short essay with a minimum of 150 words and a maximum of 500 words describing why Nominator would like to nominate someone who they feel deserve a pair of tickets to see Taylor Swift August 4, 2023 at SoFi Stadium in Los Angeles, CA. (each a "Nomination").
 - 1. Nominators may not nominate themselves.
 - 2. Nominators are not eligible to win or receive a prize in this Contest.
 - 3. Only the first 500 words of any essay submitted will be read (longer essays will not be disqualified).
 - b. By submitting an essay to the Station, each Nominator authorizes the Station to post such essay and/or Nominator's and Nominee's name to the Station's website at kson.com and/or to read it on-air.
 - c. Station reserves the right to edit an essay in its sole discretion. Not all essays will be posted to the Station's website and/or read on-air.
 - d. Essays need not be truthful. Station shall have no obligation whatsoever to verify the truthfulness or accuracy of any essay submitted in this Contest, even if such essay is submitted with an entry selected as the winning entry.
 - e.  - f. As part of the entry process, Nominator may be provided with an opportunity to opt-in to receive solicitations from, and/or to become a member/participate in clubs of (i.e., email clubs, text clubs, and rewards programs), the Participating Stations; provided, however, agreeing to receive such solicitations and/or accepting such membership is not a condition of entry into this Contest and will not increase your chances of winning.
- 3. By submitting a Nomination, Nominators and Nominees understand and agree that Station may elect to use any submitted Nomination for entertainment purposes on-air and may choose to "make fun" of any submitted Nomination. Nominators and Nominees waive any right to make any claim against

In the event it comes to Station's attention before or after Winner selection in this Contest that any such Nomination includes any plagiarized material, such Nominator and the affected Nominee shall be disqualified and any and all prizes will be forfeited.

How to Win

- 7. A total of two (2) Nominees will be deemed as a Winners, subject to verification of eligibility and compliance with the contest Rules (each a "Winner"). The Station will attempt to contact the Winner (meaning the Nominees) by telephone based on the number provided in the submitted Nomination. The Winner selection dates for this Contest are:
- a. On or about November 18, 2022, two (2) Winners will be selected from all entries received by 12:00am PT on November 18, 2022.

All non-selected Nominations will be retained and included in all subsequent drawings in this Contest.

- 8. Odds of winning the Prize in this Contest shall depend upon the number of entries received in the Contest.
- 9. PRIZES WILL BE AWARDED TO THE SELECTED NOMINEES WHO WILL BE THE ONLY PERSONS ACKNOWLEDGED AS WINNERS IN THIS CONTESTS. The winner(s) and any guest(s), if applicable, must comply with any and all COVID-19 vaccination, screening, testing, safety and related requirements imposed or required by (if applicable) the Station, the venue, event promoter, sponsors, travel providers, hotels, governmental authorities or others in connection with the receipt, use, and redemption of the prize.
