

Boots and Bags Official Rules

These rules are specific to the above sweepstakes conducted by Audacy Operations Inc. (the “**Contest Administrator**”) and its certain affiliated companies and radio stations listed on Attachment A to these rules (each, a “**Participating Station**” and collectively, the “**Participating Stations**”). A copy of these specific contest rules and the Participating Stations’ general contest rules are available on the contest rules page of each of the Participating Station’s websites listed on Attachment A to these rules. **As a preventative measure in light of the COVID-19 (Coronavirus) pandemic, copies of the specific contest rules and the Participating Stations’ general contest rules will not be available at the Participating Stations’ studios.**

Notwithstanding any provision of any Participating Station’s general contest rules to the contrary, these official contest rules shall govern this particular contest in the event of any conflict.

Listeners of any Participating Station, and visitors to any Participating Station website listed on Attachment A or Audacy.com may enter and potentially win this contest.

Who Can Enter

2. **THIS CONTEST IS SUBJECT TO AND GOVERNED BY APPLICABLE FEDERAL, STATE AND LOCAL LAWS, STATUTES, AND REGULATIONS. PARTICIPATION IN THIS CONTEST IS VOID WHERE PROHIBITED OR OTHERWISE RESTRICTED BY LAW.**

 - u. Entries will only be valid for the one (1) drawing they were received before. Entries will NOT be retained or included in any subsequent drawings in this Contest.



10. The potential Winner(s) will be notified within three (3) days at the phone number and/or email address such Entrant provided when completing their online entry to this Contest. Contest Administrator is only required to leave one voicemail and/or send one email. Notification is deemed to have occurred immediately at the time the Contract Administrator communicates such notification. Contest Administrator reserves the right, but not the obligation, to attempt to contact any Winner(s) more than once, in its sole and absolute discretion, and will not be required to attempt to contact Winner(s) an equal number of times or in the same manner. If a potential Winner cannot be contacted, or if a potential Winner does not contact the Contest Administrator by telephone or email within twenty-four (24) hours of notification from Contest Administrator, Prize will be forfeited and the Contest Administrator has the right, but not the obligation, in its sole discretion, to select an alternate Winner in a random drawing of all remaining eligible online entries received.

Prize(s)

11. Exact date and time of virtual meet and greet will be disclosed after winning. Winners must download the free Zoom application on their cell phone, laptop, desktop, or tablet in order to participate. Winners must access the meeting using their legal name only. Station is not responsible for the failure of a winner to access the Zoom video meeting due to technical or other reasons. The Zoom video meeting may be live streamed via the Internet or via one or more social media platform, and/or recorded by the station and played back in portions or in its entirety on-air, on the station website, and/or on the station's social media pages, and by logging into and/or participating in the Zoom video meeting winners consent to the station's use and distribution of the Zoom video meeting as provided herein and in the station's general contest rules. - a. Contest Administrator is not responsible if a winner and/or his/her guests are unable to meet such celebrity or participate in the associated activity if the celebrity determines this is not allowable for any reason or fails to appear/participate for any reason, including without limitation any illness, act of god, scheduling conflict or any other reason. In such event, Contest Administrator is not responsible for such portion of the Prize, which has no monetary value, and no alternate Prize will be awarded and the event/activity will not be rescheduled. In the event that Contest Administrator elects, at its sole discretion, to attempt to reschedule any such event/activity or offer an alternate Prize, Contest Administrator will have no obligation whatsoever to offer any other alternate Prize if such attempt to reschedule or other offer is not accepted by or utilized by winner for any reason whatsoever.

Sponsor(s)
