

ROAD TO STAGECOACH CONTEST RULES

These contest rules are specific to the above contest conducted by Audacy California, LLC d/b/a KSON-FM (collectively, the “**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. How to Enter

1. No purchase or payment of any kind is necessary to enter or win the Road to Stagecoach (the “**Contest**”). A purchase or payment will not increase your chance of winning.

From 12:00 AM (PT) on January 6, 2025 through the earlier of either at 12:00 AM (PT) on April 18, 2025 or the point at which fifty (50) prizes have been awarded in this Contest, whichever is sooner, go to www.kson.com/contests, click on the link to enter this Contest, and complete the entry form with all applicable and required information. **THE CONTEST WILL NOT BE CONDUCTED ON JANUARY 20 OR FEBRUARY 17 OF 2025.**

This Contest shall commence at 8:05 AM (PT) on January 27, 2025 and conclude on the earlier of either at 8:05 AM (PT) on April 18, 2025 or the point at which fifty (50) prizes have been given away in this Contest, whichever is sooner.
