\$250 for a first violation; \$275 for a second violation committed within 18 months of the first violation; \$300 for a third or subsequent violation all of which were committed within a period of 18 months.

Failure to pay the penalty shown, or to contest liability in a timely manner shall be deemed an admission of liability and may result in a default judgment entered against you. Failure to respond to this notice by the due date will result in an additional penalty of \$25 and may be subject to collections.

TO REQUEST A COURT DATE: The registered owner listed on the Notice of Liability is the only authorized person(s) to request a hearing and appear at a court date. This Notice is not subject to discretionary reduction. You cannot plead to a lesser offense, and the fine cannot be reduced. You may contest the imposition of this fine by signing and mailing the remittance below. Your request must be received by <DUE DATE>. Upon receipt, you will be notified of the date, time and location of your hearing.

**RENTAL** / **LEASED VEHICLES:** The lessor of a vehicle shall not be found liable for the violation of subdivision 1174(a) provided that the lessor sends the following documentation to PO Box 1310 Newington, VA 22122, within 37 days: (i) A copy of the rental or lease agreement; (ii) name and address of the lessee; and (iii) the Notice number as listed on page 1.

STOLEN VEHICLE OR REGISTRATION PLATE: If the basis of your claim is that your vehicle or license plates were stolen at the time of the violation, attach a certified copy of the police report with the form below. Your supporting documentation will be reviewed and will result in either dismissal of this violation or the scheduling of a court hearing. You will be notified in writing of any action taken.
