

2022 Pro Football PickEm Contest Rules WEEI-FM

These contest rules are specific to the above contest conducted by **Audacy Massachusetts, LLC**, d/b/a WEEI-FM (“**Station**”). Except to the extent specifically set forth below with respect to this specific contest, the Station’s general contest rules apply to this contest as well. **A copy of these specific contest rules and the Station’s general contest rules are available on the Station’s website at www.weei.com/rules.** As a preventative measure in light of the COVID-19 (Coronavirus) pandemic, copies of the specific contest rules and the Station’s general contest rules will not be available at the Station’s studio. **To the extent the general contest rules differ from these rules, these rules will govern and control with respect to this contest.**

How to Enter

1. No purchase is necessary to enter or participate in the WEEI 2022 Pro Football PickEm Contest (“**Contest**”).
2. For purposes of this Contest, a “**Contest Week**” means Tuesday at 12:01am (ET) through the published cutoff time for each game as posted on the picks page of Contest selection page. To participate in any or all Contest Week(s), you will need to visit your account at any time after Tuesday at 12:01am until fifteen (15) minutes before the start time of the last listed game of that week to make your picks for that week.
3. Beginning at approximately 12:01am (ET) on Wednesday, August 31, 2022 through fifteen (15) minutes before the start of the last listed game in any particular Contest Week through January 8, 2023:
 - a. Go to the contest page on the Station website, <https://www.audacy.com/weei/contests>;
 - b. Click on the Contest link;
 - c. Complete and submit the online entry/registration form (each completed entry an “**Entry**” submitted by an “**Entrant**”). Entrants must submit all information required on the entry form, which may include first and last name, telephone number, email address, home address, and/or date of birth. Entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an Internet access provider, online service provider or other organization that is responsible for assigning the email address or the domain associated with the submitted email address. Multiple entrants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an Entry shall not be deemed proof of receipt; and
 - d. For each Contest Week, (i) select which team you believe will be the winning team for each of the pro football games listed for that Contest Week; and (ii) predict the final score of the designated tie-breaker game.
 - e. All games will use a rolling lock system which will allow Entrants to make picks up to approximately fifteen (15) minutes prior to the official kick-off time of each game. Any selections submitted after the deadlines are considered invalid, and no points will be awarded. All times displayed on the schedule are Eastern Time. You may change your pick for any game up until the time that game is locked. Entries must be completed on time. Once a game is locked, you may not change your pick for it. If you did not make a pick for a particular game, it is counted as a loss, and you will receive zero (0) points for that game. If you submit a partial Entry and either forget or are unable to complete it, all games that you did not make a pick for will count as losses and you will receive zero (0) points for each game you did not submit a pick for.

How to Win

4. For each game winner an Entrant correctly predicts, the Entrant will receive points based on the following point schedule: Regular Season Games – one (1) point. Any incorrect entries will receive 0 points. If a game is canceled, postponed, or forfeited for any reason, or if a game ends in a tie, no points will be awarded for that game. The Entrant who has the highest overall score at the end of the Contest will receive the one (1) Overall Grand Prize (as described in Section 6 below), subject to verifications of eligibility and compliance with the Contest Rules (the “**Overall Grand Prize Winner**”). The maximum point total for correctly determining the winning team in every game played during the designated season is 272. The maximum point total for each week is up to 16 points. In the event of a tie, refer to the tiebreaker rules below.
 - a. **Overall Grand Prize tiebreakers:**
 - i. Overall Grand Prize tiebreaker #1 – the Overall Grand Prize Winner will be the tied Entrant who has

the highest number of wins for Week 17

- ii. Overall Grand Prize #2 - the Overall Grand Prize Winner will be the tied Entrant who has the highest number of wins for Week 16
 - iii. Overall Grand Prize #3 - the Overall Grand Prize Winner will be the tied Entrant who has the highest number of wins for Week 15
 - iv. Overall Grand Prize #4 – the Overall Grand Prize Winner will be selected in a random drawing of all remaining tied Entrants.
5. Being in a private group has no impact on winning in this Contest. It is simply for entertainment purposes. The winner within any private group is not entitled to any prizes in this Contest, unless they win in accordance with these Contest rules from among all of the Station Entrants.

Prize(s)

6. The one (1) verified Grand Prize Winner of this Contest will receive: one (1) \$500.00 American Express e-Gift Card.

Odds of Winning

7. Odds of winning depend on the total number of eligible entries received and the relative professional football knowledge of all entrants.

Other Rule(s) Specific to this Contest

9. ENTRANTS UNDERSTAND AND AGREE THAT, DUE TO COVID-19 (CORONAVIRUS), GOVERNMENT REGULATION, DISASTERS, STRIKES, CIVIL UNREST OR DISORDER, OR OTHER CAUSES, THE 2022-2023 U.S. PROFESSIONAL FOOTBALL SEASON MAY NOT BE CONDUCTED AS ORIGINALLY SCHEDULED. ACCORDINGLY, THIS CONTEST MAY BE SUSPENDED OR CANCELLED BY THE STATION AT ANY TIME IF THE 2022-2023 U.S. PROFESSIONAL FOOTBALL SEASON IS SUSPENDED, POSTPONED, OR CANCELLED. IF THE PROFESSIONAL FOOTBALL SEASON AND/OR THIS CONTEST IS SUSPENDED OR CANCELLED, THEN THE HIGHEST OVERALL SCORE WILL BE CALCULATED BASED ONLY ON THE GAMES FROM CONTEST WEEKS THAT WERE COMPLETED PRIOR TO THE SUSPENSION OR CANCELLATION OF THE PROFESSIONAL FOOTBALL SEASON AND/OR CONTEST, PROVIDED, HOWEVER, THAT IF FEWER THAN FIVE (5) CONTEST WEEKS ARE OR WERE COMPLETED PRIOR TO THE SUSPENSION OR CANCELLATION OF THE PROFESSIONAL FOOTBALL SEASON AND/OR CONTEST, THE STATION RESERVES THE RIGHT TO NOT AWARD A PRIZE IN THIS CONTEST.
10. IN THE EVENT THAT DURING A CONTEST WEEK ONE OR MORE GAMES ARE CANCELLED, SUSPENDED, DELAYED OR POSTPONED FOR ANY REASON, THEN SUCH GAME(S) WILL BE EXCLUDED FROM THE CONTEST THAT WEEK, AND NO POINTS WILL BE AWARDED FOR SUCH GAME(S).
11. For entertainment purposes only, one (1) or more Station employees may talk about their picks and/or how they are doing in this Contest. Such employees may appear on the stats pages as Entrants in this Contest and/or winners or leaders in this Contest. Notwithstanding the foregoing, in no event will any Station employee be an eligible participant in this Contest and shall not be entitled to win any prizes in this Contest. In the event that a Station employee is selected by the Software Provider software (*as described in Section 13 below*) as a winner, he/she shall be deemed ineligible and Station will manually award the Entrant with the highest score(s) (as set forth in Section 4) to be winners in this Contest.
12. The entry process may require Entrants to login to, or to create, a free account with the third-party provider of a software platform used by the Station for such Contest(s) ("**Software Provider**"), by going to the Website, clicking on the Contest entry link, and completing and submitting the online registration form with all required information.
- a. Limit one (1) account with the Software Provider per email address.
 - b. Software Provider is not a sponsor of this Contest, but Entrants may be required, as part of the entry process, to agree and consent to the Software Provider's terms of service and/or privacy policy, both of

which will be available via a link during the entry or account registration process (collectively, the “**Software Provider Policies**”).

- c. If the Entrant elects to have their entry form pre-loaded or pre-populated with information from the Entrant's Facebook, Twitter, Google, or LinkedIn profiles, such Entrant authorizes the Software Provider and the Station to access, utilize and/or pre-load to such entry form, applicable portions of Entrant's profile information from such account.
 - d. While agreement to the Software Provider Policies may be required in order to enter the Contest, the Software Provider Policies are not a part of these Contest Rules but are a separate agreement between the Entrant and Software Provider. In the event of any conflict between the Software Provider Policies and the Rules, the Rules will govern.
 - e. Station is not responsible for any error or technical malfunctions associated with the Software Provider site that may affect any Entrant's ability to enter, to win, or to be properly considered in the Contest, regardless of the cause. In the event of a malfunction associated with the Software Provider site that the Station in its sole and absolute discretion deems to materially and adversely affect the Contest, the Station reserves the right to (1) suspend the Contest; (2) terminate the Contest without a Winner; (3) terminate the Contest and select a Winner early; (4) provide alternative means of entry; and/or make any other changes to the Contest that the Station deems appropriate under the circumstances. Any such changes, terminations or suspensions will be published on the Contest Rules Page, and in the Station's sole and absolute discretion, may also be announced on-air, published elsewhere on the Website, and/or published on social media.
 - f. Employees of Software Provider and its affiliates, their respective parents, affiliates, subsidiaries, advertising sponsors and promotional agencies, and the immediate family members of each are not eligible to win in this Contest.

All references to any football name or term is purely nominative and not intended to imply any connection, affiliation, or endorsement. This Contest is not affiliated with or endorsed by the NFL or any NFL team or Facebook.
15. **This game may not be used in connection with any form of gambling. This game is strictly for entertainment purposes only and in connection with the Contest described above.**
16. This Contest may be suspended or cancelled by the Station at any time if the professional football season is suspended or cancelled.
